(AUCTION NOTICE)

A public auction of Mango trees existing in BOPs (Alipur, Kistopur and Kumarpar) of 82 Bn BSF on lease basis will be conducted on **03/10/2017 at 1000 hrs** at Bn HQ Narayanpur, Malda (West Benal).

2. The said auction will be for a duration of one year with effect from 03.10.2017 to 02.10.2018.
3. All the authorized bidders can participate and bid for auction.
4. All bidders will have to get themselves registered with the Board of Officers at least one hour before the commencement of auction and separately deposit a sum of Rs. 2000/- (Rupees Two thousand) only as earnest money which will be adjusted/refunded as the case may be after the auction.
5. The earnest money so deposited will be refunded immediately on completion of auction except the successful bidder, whose money may be adjusted against bid amount.
6. The final bidder will have to deposit total value of auctioned trees in cash and prescribed taxes (sale tax & surcharge) soon after the auction bid is over.
7. In case final bidder fails to deposit the total amount of bid on the spot, his earnest money will be forfeited.
8. The auction of Mango trees on lease will be held on "As is where is basis".
9. The highest bidder will have to take the trees on lease for one year only.
10. In case bandh call in WB on the day of acution, the same will be conducted in next working day.
11. No security will be provided to the successful bidder by the unit for looking after the trees.
12. The commandant 82 Bn BSF reserves the right to accept/reject any or all of the bids without assigning any reason thereto at any stage.
