1. A Public Auction of the following types of condemned stores on as is where is basis will be held at HQ 81 Bn BSF Seemanagar Nadia (W.B) on 26 June'2019 at 1000 Hrs.
  - a) Provisioning Store like Misc/Tantege/Defence/Welfare/Utensil/Sports/Barrack Property/Old News Paper/Training items etc.
  - b) Empty packing material of Magazine .
  - c) MT US Spare Parts, Tyres, Tube, Battery and Burn oil.
  - d) Communication Stores.
2. In case of any bund/strike in West Bengal State on the same day then the auction will be conducted on the next working day.
3. All eligible bidders will have to register themselves with the office of the Commandant 81 Bn BSF one hour prior to auction of stores. They will have to deposit Rs.10,000/- (Rupees ten thousand ) only in cash as earnest money which will be refunded/adjusted after the auction. They shall have also bring their residence proof i.e Aadhar Card, Voter ID, PAN Card and GST Registration No.
4. The successful bidder will have to pay 100% bid amount plus Taxes I,e GST/VAT etc. as applicable as per West Bengal State Govt. in cash, on the spot, Immediately after the auction of the particular stores is over. Decision of the of board of officers shall be final.
5. In case the final bidder fails to deposit the cost of the auction store on the spot, earnest money deposited by him/her will be forfeited.
6. The Auction will be held as per Departmental Rules and Regulations.
7. Successful bidders has to lift the auctioned stores within 12 hrs under his own arrangements and no transportation would be provided by the unit for the same.
8. If successful bidder fails to lift the auctioned store within stipulated time a levy of 2% of total auctioned value/ 12 hrs will be charged.
