
- i) Communication stores as well as computer with its accessories

3. All bidders must be in possession of their PAN Card and Income Tax clearance certificate in original which will be scrutinized by the board of officers, failing which they will not be allowed to participate in the auction.
4. The bidders will be allowed to inspect the stores before bidding.
5. Successful bidders will have to deposit the value of auctioned store plus admissible taxes/surcharge immediately after the action is over and store has to be lifted within 03 days from the date of auction under his own arrangement.
6. In case the final bidder fails to deposit the cost of auctioned stores on the spot, his earnest money will be forfeited and condemned stores will be put for auction again after obtaining approval of the Competent Authority of this HQr.
7. Transport and labour will not be provided by this HQ for carrying /shifting of auctioned stores.
